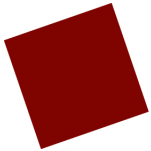

The activities of daily living include: bathing, continence, dressing, eating, toileting and transferring. No accelerated benefits will be paid under this rider during the first 2 years it is in effect. After a 90 day waiting period, the policyowner can accelerate up to 24% of the initial death benefit amount annually. The benefit can also be accessed monthly up to 2%; quarterly up to 6% or semi-annually up to 12% of the death benefit. The maximum amount of lifetime benefits that can be accelerated for an insured is 90% of the initial face amount or \$500,000, whichever is less. However the actual payment will be, minus adjustments, less than the portion of the death benefits accelerated because the benefits are paid prior to death. Benefits may be subject to taxation. A critical illness is one of the qualifying events: heart attack, stroke, ALS (Lou Gehrig's disease), diagnosis of certain cancers, kidney failure and major organ transplant. After a 30 day waiting period, the policyowner can access the death benefit up to the maximum total amount of lifetime benefits for an insured under all accelerated death benefit riders, which is \$500,000. However the actual payment will be, minus adjustments, less than the portion of the death benefits accelerated because the benefits are paid prior to death. Benefits may be subject to taxation. Unemployment Benefit Rider	Unemployment Benefit Rider: This extra benefit provides for waiver of monthly premium payments deposited into Your Policy Value in the event of involuntarily unemployment for three consecutive months after a 90 day waiting period.
